It is understood by the owner/handler that every dog at this event shall at all times be in the care, control, and custody of the owner/handler who also agrees to assume full responsibility for the animal and its actions at all times. It is further understood that the undersigned owner/handler agrees to indemnify and hold harmless the High Plains Schutzhund Club, its officers, its members, and all property owners from all liability, claims and causes of action which he/she may have arising from participation in this event.
