As lawful consideration for being permitted by CLUB to engage in these activities at the BOGGS PROPERTY or TRACKING GROUNDS, I hereby release, waive, discharge, and relinquish any action or causes of action for personal injury, property damage, or wrongful death, against Steve or Marsha Boggs, the CLUB, THE BOGGS PROPERTY AND/OR TRACKING GROUNDS, and his/her/their/its heirs, executors, administrators, successors and assigns, which may hereafter arise from the activities sponsored by the CLUB or any pursuit incidental thereto.

I hereby agree that under no circumstances shall I prosecute or present any claim against Steve and/or Marsha Boggs, the CLUB, BOGGS PROPERTY AND/OR TRACKING GROUNDS for any causes of action for personal injury, property damage, or wrongful death, whether the same shall arise by negligence or unintentional conduct of anyone participating in the activities sponsored by the CLUB or any pursuit incidental thereto.
